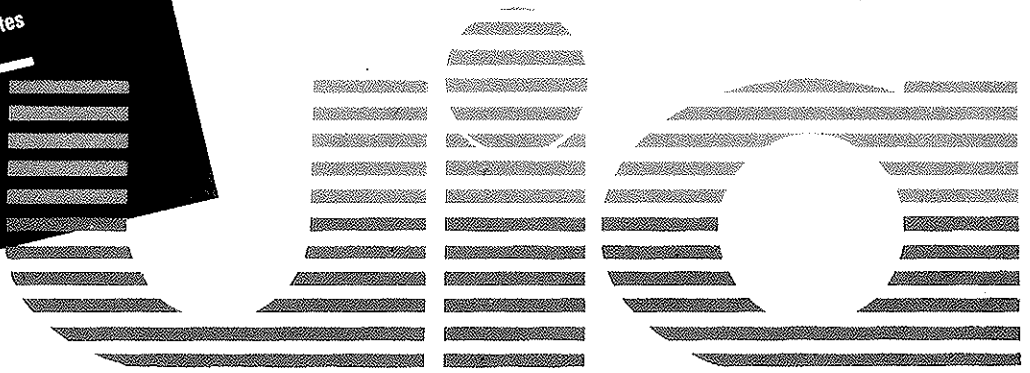

DECLARATION OF INTERDEPENDENCE FOR A SUSTAINABLE FUTURE U.I.A. - A.I.A Chicago, 18-21 June 1993

After the Assembly and Congress in Chicago, a Declaration on behalf of the architects of the world was adopted. We publish the text in extenso.

IN RECOGNITION THAT :

. A sustainable society restores, preserves and enhances nature and culture for the benefit of all life, present and future ; a diverse and healthy environment is intrinsically valuable and essential to a healthy society ; today's society is seriously degrading the environment and is not sustainable ;

. We are ecologically interdependent with the whole natural environment ; we are socially, culturally and economically interdependent with all of humanity ; sustainability, in the context of this interdependence requires partnership, equity and balance among all parties ;

. Buildings and the built

environment play a major role in the human impact on the natural environment and on the quality of life ; sustainable design integrates consideration of resource and energy efficiency, healthy buildings and materials, ecologically and socially sensitive land-use and an aesthetic sensitivity that inspires, affirms and ennobles ; sustainable design can significantly reduce adverse human impacts on the natural environment while simultaneously improving quality of life and economic well-being ;

As members of the world's architectural and building-design professions, individually and through our professional organizations, we

COMMIT OURSELVES TO ;

. Place environmental and social sustainability at the core of our practices and professional responsibilities ;

. Develop and continually improve practices, procedures, products, curricula, services and standards that will enable the implementation of sustainable design ;

. Educate our fellow professionals, the building industry, clients, students and the general public about the critical importance and substantial opportunities of sustainable design ;

. Establish policies, regulations and practices in government and business that ensure sustainable design becomes normal practice ;

. Bring all existing and future elements of the built environment - in their design, production, use and eventual reuse - up to sustainable design standards.

Jaime DURO PIFARRE

Aged 49, Jaime Duro Pifarre is a graduate of the Higher Technical School of Architecture in Barcelona. He is in private practice in the Catalan capital and, as architect and town planner, is involved in a wide range of projects in the public and private sectors.

Jaime Duro Pifarre is President of the Consejo Superior de los Colegios de Arquitectos de Espana and head of the

Spanish delegation for the Architects' Council of Europe (ACE). He is member of the UIA Council since 1990, and as President of the Union succeeds Olufemi Majekodunmi.

Vassilis SGOUTAS

Vassilis Sgoutas is in private practice in Athens. His works include public buildings, industrial and commercial projects in Greece and the Middle East. As UIA Council member from 1985 to 1990, and as Vice-President for Region II from 1990 to 1993, he has participated in several of the Union's activities. He has also been active in the EEC Helios programme for the handicapped. He succeeds Nils Carlson as UIA Secretary General.

Enrico MILONE

Enrico Milone is in private practice in Rome. His works includes hospital buildings, planning and area planning projects. He teaches architectural design at the University of Rome. Member of the National Council of Italian Architects (1980-1985), he is President of the Italian Section of the UIA. He succeeds Pdraig Murray as Treasurer of the UIA.

Kok Leong CHIA

Graduate of the Institute of Technology of Helsinki, Gunnel Adlercreutz is in private practice since 1979, working mainly on housing, public buildings, leisure amenities and urban planning. Her firm has taken part in numerous competitions in the Nordic Countries.

Very active in the Association of Finnish Architects -SAFA- of which she was Vice-President in 1992 and 1993, she was also President of the UIA Nordic Section from 1987 to 1993. She is member of the UIA Council since 1990.

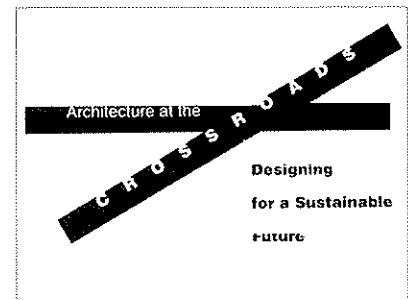

COMING UIA CONGRESSES

UIA Assembly at its meeting in Montreal in 1990, chose Barcelona as the venue for the 1996 UIA Congress. The theme of this event, to be held from 3 to 7 July 1996, will be "new life for old cities".

In Chicago, the candidature of the Peoples' Republic of China obtained the largest number of votes by the Assembly, followed by the Republic of Korea. Turkey and the Philippines tied for third place.

**INTERNATIONAL CONFRONTATION OF PROJECTS BY STUDENTS OF ARCHITECTURE
1993 UNESCO PRIZE FOR ARCHITECTURE**

Traditionally organized in conjunction with UIA world Congresses, the international confrontation for students of architecture took place this year around a programme launched by the American Institute of Architects. It was a call for ideas in favour of a sustainable built environment, likely to have a positive effect on building design, construction techniques and community development during the coming fifty or

hundred years. The jury for the confrontation met in Chicago from 13 to 15 June 1993.

Presided over by Allan Rodger, Professor of architecture at the University of Melbourne, the members were : Olufemi Majekodunmi, President of UIA, Joseph Esherick, architect, AIA Gold Medalist, Hazel Henderson, international economics critic, John Lyle, landscape architect, Wolf Tochtermann, architect, Director of the division for population, human habitat and studies on development at UNESCO and Wilhelm K. Åcker, architect, Director of the UIA Programme for International Competitions.

On the occasion of each Confrontation, UNESCO awards a special prize of 7 000 US \$ and UIA National Sections are also invited to offer prizes. This year the Japan Institute of Architects, the Consiglio Superior de los Colegios de Arquitectos de Espana and the Architectural Society of China replied to this invitation. Finally, a Prize in memory of the late architect Henri Calsat, Secretary of the UIA work Group "Habitat", was generously offered by his widow.

JURY'S COMMENTS

The jury was favourably impressed by

the capacity shown by the future architects to reflect and to confront the major challenges of the future, and by their consciousness as professionals and citizens of the world. The jury also remarked that, on the whole, the best proposals came from students in developing countries.

The latter proved their ability to think in a subtle and systematic manner, transcending stereotypes and conventional professional barriers. This quality may be perceived in the majority of their projects.

1993 UNESCO PRIZE FOR ARCHITECTURE

The jury awarded this prize to Chan Elmas, student at the University of Portland (USA) for his "beautifully presented" project, "developed to a high level of detail. Practical in its possibilities, it is an example of what could and should be done".

JAPAN INSTITUTE OF ARCHITECTS PRIZE

This prize, worth 5000 US \$, was awarded to a team from the Chulalongkorn University in Bangkok (Thailand), composed of Sawangrat Somkitsiri, Sirinat Bhromnarurith, Somklet Songpetmonkol, Thida Thongtai, Surashai Yeamsiri, Lert Ngamkajornvivat. "Starting with a poor water-based

squatter settlement, this scheme proposes to enhance the quality of living while retaining opportunities to continue traditional ways of life and traditional behavior patterns".

PERES PINERO PRIZE

Kyle William Anderson (U.S.A.) for her part focused on the hydrological cycles as they affect medium density settlement. She is winner of the "Perez Pinero Prize", offered by the Spanish Section of the UIA, which includes a grant of 1000 \$ and a trip to Spain.

H. JEAN CALSAT PRIZE

The Cuban team from the ISPJAE, composed of Dagnis Canizarez Leiva, Milagros Ortiz Coblencz, Jose Ernesto Planas Garcia, Adiel San Miguel Estevez, won this prize for the imaginative effort shown in their project to reintroduce the key elements of sustainability.

The H. Jean Calsat Prize is worth 1000 US \$. The winner received an additional prize of 2 000 US \$ (*).

ARCHITECTURAL SOCIETY OF CHINA PRIZE

Students at the California State Polytechnic University (Pomona), Ken Chan, Dan Davidson, A. Jose Estrada, Ashini Fernandoi and Kiku Kurahashi received an award for their project on the

improvement of a degraded urban environment. They are invited by the Architectural Society of China to visit that country.

The team also received a prize of 1000 \$ (*).

A number of companies in the United States generously supported this competition.

The following prizes were awarded by the AIA thanks to their help.

. Konijan Yu and Qingping Ji, University of Harvard, received a prize of 1 000 \$ for their project on eco-tourism.

A team from the Xian Institute of Metallurgy and Construction Engineering, China, composed of Ai Hongbo, Chen Jian, Dai Jun, Deng Xiangming, Jin Xiaoman, Liu Xiangdon, Ma Jian, Qian Hao, Sang Hongmei, Ye Lei, Zhang Qun, Zhang Yu, Zhang Zhaohui and Zhao Lin received a prize of 3 000 US \$.

Their project "integrated sustainability issues with history, cultural and behavior patterns".

. Peggy Hartzel, student at the University of Phoenixville Highschool received a prize of 700 US \$ for her urban ecology project, a "great example of sensitive development and re-use of a derelict industrial environment".

MASTERPLAN FOR THE NEW CAMPUS OF THE UNIVERSITY OF CYPRUS RESULTS

AN ARCHITECTURAL CHALLENGE

In the autumn of 1992, an open and anonymous international ideas competition in two stages, was launched for the masterplan of the new campus of the University at Athalassa, near Nicosia. Focal point of the cultural aspirations of the Cypriot society, this project is one of the major architectural challenges launched since the independence of the country.

The competition called for the design of a built complex of over 147 000 M², on a site of 139 hectares. It was approved by the International Union of Architects (UIA).

The organizers of the competition received 156 projects from 43 countries.

JURY

The jury met for the first time in January 1993. It was composed of N. Polydorides (Cyprus), urban planner and member of the Board of the University, T. Sieverts (Germany), architect, W. Porter (USA), architect, T. Takahashi (Japan), architect and UIA representative, A. Daveronas (Cyprus), architect, nominated by the Association of Cypriot Architects and Engineers, Y. Michael (Greece) and A. Schweighofer (Austria) also took part in the meeting as deputy-members.

FIRST STAGE RESULTS

At the end of the first meeting, the jury retained 9 projects the authors of which were invited to participate in a second phase.

These teams were : M. Cucinella (France), J.-P. Durig (Switzerland), HRTB A/S arkitekter MNAL (Norway), S. Moshe (Israel), OMATHA SYNANTISI (Cyprus), Photiou Architects Ltd/Maguire & Co International (Cyprus), Seymour Harris Partnership/Studio BAAD (United-Kingdom), The John S. Bonnington Partnership (United-Kingdom), Sophia Xenopoulou (Greece). Each team received the sum of 10 000 US \$.

FINAL WINNERS

The second jury meeting took place from 2 to 5 July 1993. The composition of the jury was the same as for the first stage with one exception: Anton Schweighofer, replacing the absent T. Sieverts, became a full member. The jury examined the work submitted by the 9 teams admitted to the second stage and at the outcome of the deliberations the prizewinners were unanimously declared to be:

FIRST PRIZE:

Team led by Jean-Pierre DURIG and Philippe RAMI, with the participation of Raffaella TADDEI, Eugen EISENHUT, Carmen CAMPANA (Switzerland). Prize - 50 000 US \$

SECOND PRIZE:

Mario CUCCINELLA (France). Prize - 25 000 US

THIRD PRIZE:

OMATHA SYNANTISI", lead by Socrates STRATIS (Cyprus) - Consultant Alexandros N. Tombazis architect (Greece). Prize - 15 000 US \$.

MENTIONS:

HRTB A/S arkitekter MNAL (Norway), led by Marcin BOGUSLAWSKI, with E. HULTBERG, J. RESEN, O. MOWE, E. THRONE-HOLST, K. MØE BERDAL-STROMME (consultant engineers) and B. AASEN (landscape architect).

The John S. Bonnington Partnership, I. GRAHAM, (United-Kingdom). Each honourable mention was accompanied by a prize of 10 000 US\$

THE WINNING PROJECT

The jury selected this project for the clarity of organization and efficient construction. "It is remarkable that within

such a clear order, this scheme also offers flexibility of growth, and that it holds the potential for spatial and architectural variety, for a rich and interactive university life, and for a convincing relation to the city".

URBAN DESIGN OF SPREEINSEL, BERLIN

A new international competition is launched in Berlin, now headquarters of the Government of the Federal Republic of Germany, for the development of the Spreeinsel site, in the historic centre of the city, where a concentration of facilities is planned which will include the Foreign Office and the Federal Ministry of the Interior. This competition has received the approval of the International Union of Architects.

AN OPEN APPLICATION FOR SELECTION

This ideas competition will be preceded by a selection phase, anonymous and open to professionals throughout the world having the right to practice the profession in their countries.

Architects wishing to take part must submit graphic documents expressing their urban design concept (1 overall plan at 1:2000 and an isometric drawing) as well as a brief written report (1 page). The jury will select about fifty proposals from amongst those submitted and their authors will be invited to participate in the ideas competition.

JURY COMPOSITION

Architects, individually or in teams, wishing to participate in the selection phase, should make a written application

to the organizers accompanied by a registration fee of 50 DM (in the form of a cheque).

The languages of the competition are English and German.

The 50 candidates selected to participate in the competition will each receive the sum of 5 000 DM (approx. 3 000 US \$ or 15 000 FF). The jury will award a total of 300 000 DM to the winners of the competition.

Deadline for mailing projects for selection phase: 22 October 1993

Selection of the 50 participants: 7 December 1993

Following the announcement of the selection, the 50 competitors will have 12 weeks to design their projects.

BENEDICTUS AWARDS

The company DuPont Worldwide, has created an international programme for architecture, the Benedictus Awards, to recognize innovation and quality in the use of laminated glass. The 1994 edition of the awards was officially announced in Chicago during the XVIIIth world architects congress and is under the patronage of the UIA (International Union of Architects), the AIA (American Institute of Architects) and ACSA (Association of Collegiate Schools of Architecture).

The awards programme is divided into two categories ; one open to professionals for completed works ; the other, open to students of architecture, is based on a specific programme.

SIR NORMAN FOSTER, WINNER OF THE 1993 BENEDICTUS AWARD

Sir Norman Foster & Partners, a British firm, won the first international Benedictus award, for the design of the new terminal at Stansted Airport,

London, featuring laminated glass lattice shell domes, glass walls and fully-glazed elevators.

1994 BENEDICTUS AWARDS, PROFESSIONAL CATEGORY

This award is open to architects from all over the world and the winner will be presented with a glass sculpture designed by the German artist, Hans Godo Frabel. Architects wishing to take part must submit a portfolio on a specific completed work, together with a report, written in English, explaining the essential role played by laminated glass in the design of the project. The deadline for receiving documents is 22 April 1994.

1994 BENEDICTUS AWARDS, STUDENT CATEGORY

This edition is open to upper-level architecture students from the United States, Canada and European countries. Each student, individually or in a team, must have the support of his/her school

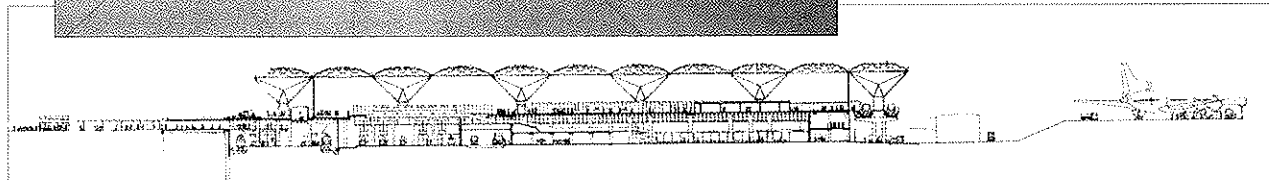
and the project must be designed as part of the school's curriculum. The deadline for receiving registrations is 8 March 1994 and for projects 22 April 1994. The programme set by the organizers for this edition is associated with the commemoration of the 70th anniversary of the foundation of the Bauhaus. Competitors are invited to integrate new glass technologies and most particularly those permitting the use of laminated glass, in an extension to the Bauhaus School of Architecture in Weimar, close to the symbol™ building constructed by Henry van de Velde, between 1905 and 1911. A total of 14 000 US \$, will be awarded in prizes by the jury.

THE 1994 JURY

One jury has been appointed for both categories. It is composed of William Mc Donough (USA), Cesar Pelli (USA), Richard Rogers (United-Kingdom) and Erhard Schültz (Germany) and will deliberate in May 1994.
