ACTIONS

OBJECTIVE

Let the architects innovate the public spaces from the knowledge of their transformations on several continents.

- Research about Renewal of Public Spaces to the best well-being of the users in several regions of the world, verifying if these spaces kept the Cultural Identity and if they used a contemporary language.
